### Weddin Shire Low Earth Orbiting Satellite Internet Subsidy - Application Guidelines - 2024

### Background:

The majority of the Weddin Shire, outside of the town of Grenfell, is serviced by the NBN Satellite network. This network limits resident's ability to capitalise on the opportunities that come from reliable high speed internet, including social, health and economic opportunities. This has contributed to a digital divide in our community.

This program has been developed to improve digital connectivity across the Weddin Shire. This will be achieved by supporting access to internet coverage via the existing Low Earth Orbiting (LEO) satellite network, an alternative to the NBN network. The project involves reimbursing residents for costs incurred when connecting to the LEO satellite network. You may be more familiar with this technology by its retail name, Starlink. Eligible connections may include:

- Starlink Residential
- Starlink Business
- Starlink Mobility
- Or any other LEO satellite network.

#### **Guidelines:**

- 1. Applicants must complete a Low Earth Orbiting Satellite Internet Subsidy Application Form, and lodge it with Weddin Shire Council for assessment.
- Applicants who are rental tenants must provide evidence that their rental agent/owner has
  consented to the installation of a satellite dish. Applicants must use Appendix A of the
  Application Form.
- 3. The program will operate by reimbursement of eligible expenses into the Applicant's bank account within 30 days of approval.
- 4. The program has been developed for Weddin Shire residents who are not eligible for NBN fixed line, as per the NBN rollout map at www.nbnco.com.au/learn/rollout-map
- 5. The claim for reimbursement includes hardware costs and associated installation costs. Proof of purchase such as a tax invoice and receipt will be required.
- 6. Hardware costs include the satellite dish, router, adapter, mounts, and/or cables.
- 7. Associated Installation costs include the cost of a qualified electrical or antenna technician. Applications for 'installation costs only' will not be considered as part of this program.
- 8. Ongoing monthly usage charges are excluded under the program. This is the responsibility of the Applicant.
- 9. Ongoing charges related to operation and maintenance of the LEO satellite are excluded under this program (i.e. servicing charges, technical charges or insurances or any other associated operating and maintenance costs). This is the responsibility of the Applicant.
- 10. The maximum reimbursement is capped at \$1500 per applicant.
- 11. One application per eligible address.
- 12. There is a capped budget available for this program. The program will end when the funds are exhausted, or 30 April 2024, whichever comes first. Applicants are encouraged to apply as early as possible. In the event of an early close to the program, Weddin Shire Council will review applications in the order the applications were received. An Applicant's lack of knowledge of an early closure of the program will not be grounds for consideration of applications submitted after the program officially ends.

- 13. Stage One of the program has been developed for new LEO satellite connections made after 8 February 2024. Stage One of the program is not retrospective and expenses incurred before this date are ineligible.
- 14. Stage Two allows for customers with existing LEO satellite internet to make a retrospective claim for subsidy. Applications for Stage Two open on 1 March 2024. Applicants successful under Stage One are ineligible under Stage Two.
- 15. Upon submission of a complete application form and all necessary supporting documents, Council will check the compliance of applications with the program guidelines, in order of receipt. Incomplete applications will not enter the assessment queue or be assessed until all required information is provided.
- 16. Council will endeavor to assess applications and contact the Applicant with either an outcome (approved or not approved), or to request additional information within fourteen (14) days of application receipt.
- 17. Each application will be considered against assessment criteria. Applications will be approved by Weddin Shire Council's General Manager, in weekly batches commencing February 2024. As per point 3, approved applications will be reimbursed within 30 days of approval.
- 18. Upon the General Manager's approval of applications, payments will be processed directly into the resident's nominated bank account as per point 3.
- 19. Weddin Shire Council may request further information from the Applicant or from any business or individual the Applicant engaged, to assist in confirming compliance of the application and to verify any information provided in the application. Failure to provide such information may result in Weddin Shire Council refusing the application.
- 20. Weddin Shire Council may refuse an application where eligibility criteria are not met, or where the Applicant does not, or cannot, provide sufficient information for Weddin Shire Council to determine if eligibility criteria have been met.
- 21. Weddin Shire Council is bound by the *Privacy and Personal Information Protection Act* 1998 (*PPIP Act*). <a href="https://legislation.nsw.gov.au/view/html/inforce/current/act-1998-133">https://legislation.nsw.gov.au/view/html/inforce/current/act-1998-133</a> Council will securely dispose of all personal identity documentation no later than 31 December 2024.
- 22. These guidelines are correct at the time of publishing. Weddin Shire Council reserves the right to amend, alter or change these guidelines at any time.
- 23. Weddin Shire Council will evaluate this program with a survey on program completion.
- 24. Council accepts no liability for where, or how a satellite dish, is mounted or routed in an Applicant's building (house, shed or any other infrastructure).
- 25. The Applicant indemnifies Weddin Shire Council, its employees and agents against liability in respect of all claims, cost and expenses in relation to all loss, damage, injury or death to persons or property caused by the Applicant's Contractor or product, in connection with the provision of the hardware or associated installation, except to the extent that the Council caused the relevant loss, damage or injury.
